### MINUTES OF THE GOVERNING BODY MEETING

Date: 06.11.2020

Venue / Mode: Virtual Mode (Google Meet)

The first Governing Body meeting of the college for the year 2020-21 was held on Friday, 6<sup>th</sup> November 2020, at 10:00 a.m. through virtual mode using Google Meet. The proceedings were started with a prayer recited by Rev. Dr. M. Alphonse, S.J., Secretary. Rev.Dr.Danis Ponniah S.J., Chairman of the Governing Body & Provincial, Jesuit Madurai Province, extended a warm welcome to all the members of the Governing Body. Rev.Dr.V.Henry Jerome, S.J., Rector, and Rev.Dr.F.X.Dominic Royce, S.J., Treasurer, could not attend the meeting for various reasons.

### 1. Academic and Outreach Programmes since April 2020

Rev. Dr. S. Mariadoss, S.J., Principal-in-charge, presented the academic and outreach programmes carried out from April 2020 to October 2020. He reported that 72 academic programmes and 67 outreach programmes were organised during the COVID-19 pandemic period. He further reported that 29 webinars and 16 online guest/endowment lectures were

organized. He presented that STAND (Students Training and Action for Neighbourhood Development), one of the service organisations of the College, could reach out to 580 deserving families with food materials for a tune of Rs.4,64,000. The members appreciated the quality initiatives.

### 2. Minutes of the previous Governing Body meeting

The Minutes of the previous meeting and Action Taken Report were read out by Mr.S.Benjamin Franklin, the Dean of Arts. Dr.Ramamurthy, UGC Nominee, suggested that highlights of the minutes could be presented and that more time had to be allotted for items like ratifications, resolutions and approvals. Later, the minutes of the previous meeting were confirmed and passed.

#### 3. Report of the Admission Committee

Dr. S. Paulraj, Associate Professor and Admission Officer, presented the report on the admission process for the year 2020-21. He presented the minutes of several admission committee meetings that took place during 20<sup>th</sup> July to 23<sup>rd</sup> October 2020. He said that 11,964 applications were received this year. It was reported that due to Covid-19, the entire admission process was carried out online. And, due to heavy demand for VISCOM, a special process of interviewing candidates online was conducted by the HOD. Rev. Fr. Principal i/c said that the college attracted an addition of about 3000 applicants when compared to the overall applicants last year. He also informed the members that a Transgender has been admitted in the college. The members acknowledged such human gesture shown towards a transgender. Dr.V.S.Jospeh Albert, Deputy Principal, said that the college has followed the guidelines of the Government and the Jesuit policy of inclusiveness.

### 4. Minutes of the special Academic Council meeting

The minutes of the special academic council meeting was presented by Dr.S.P. Victor, Dean of Science. Dr. Ramamurthy Naidu clarified that the objective of an Academic Council meeting was to revisit the courses that were being offered, and to introduce new courses in the curricula. Fr. Principal in-charge replied that it was a special academic council meeting convened with a single point agenda regarding the conduction of semester examination online.

### 5. Minutes of the Planning and Evaluation Committee Meeting

The minutes of the Planning and Evaluation Committee meeting was read out by Rev.Dr. A.Ignacy, Vice Principal. Fr. Principal i/c shared that there existed a huge demand from shift two students for a separate NCC wing. But, he raised his concern over the non-availability of funds for such initiative. Fr. Secretary clarified that in LICET, there is an NCC wing operating with no grant-in-aid. The Deputy Principal said that NCC should be offered to Shift II students because it would help them get the "C" certificate which is necessary for employment opportunities in several fields. Fr. Provincial said it is the need of the students and, therefore, the possibilities of starting a separate NCC wing should be explored. It was resolved that the NCC Officer of the college should be instructed to explore the possibilities of starting a separate NCC wing for the students of Shift II.

### 6. Minutes of the Academic Council Meeting (21st Oct. 2020)

Dr. V.S. Joseph Albert, Deputy Principal, presented the minutes of the Academic Council meeting held on 21<sup>st</sup> October 2020. He informed that BMS (Bachelor in Maritime Logistics), which got approval of the Governing Body on 6<sup>th</sup> March 2020, could not be introduced in June 2020 due to Covid-19 pandemic situation. It was resolved to introduce BMS in June 2021.

### 7. Minutes of the Finance Committee Meeting

The minutes of the Finance Committee meeting held on 28<sup>th</sup> October 2020 was presented by Dr.M.Baby Mariyatra, Dean of Research and UGC Affaires. The minutes were approved. Fr. Principal i/c informed that the UGC had sent a message that Autonomy Grant could not be released in this academic year due to paucity of funds.

### 8. Report of the IQAC 2020-21

Dr. A. Lourdusamy, IQAC Coordinator, presented the IQAC report. He informed the members that the college has got a prestigious recognition as Scientific Industrial Research Organisation (SIRO) by DSIR (Department of Scientific Industrial Research). Dr. Naidu congratulated the college on having got such accomplishment.

### 9. Secretary's Report

Rev. Dr. Alphonse Manickam, S.J., Secretary, presented the Secretary's report. His presentation included the appointments of new Officials, Head and Coordinators, and the appointments of

new faculty members. He also presented the new appointments of non-teaching staff under aided stream. He focused on the new initiatives such as conversion of women empowerment centre, old canteen into new class rooms to accommodate two newly added sections of Commerce and English, and classes of II B.Sc. Physics and II BCA. He informed the members about the laying of new roads, garden and installation of 5 hand sanitizer vending machines in all offices and the library.

### 10. Report of the Semester Results: April 2020

The report of the semester results April 2020 was presented by Dr.L.Louis Jesudass, Controller of Examinations. He presented that 3572 students appeared in the semester exam while the passed out students were 3558 with a pass rate of 99.61 per cent. He also said that the pass percentages between male and female students were 99.55 per cent and 99.67 per cent respectively. The UGC representative appreciated the Controller of Exams and the College for producing such a good results and registering better student progression.

### 11. Any Other Matter

Under any other matters, Fr. Principal in-charge shared that St.Xavier's College has become a member of National Rural Entrepreneurship Mission. "Our college is one among the 162 selected colleges in India. He further said that with this initiative, the college will be able to inculcate entrepreneurship among the target groups in the STAND adopted villages. As the second point under any other matter, Fr. Principal in-charge made a proposal for initiating 'Breakfast Scheme for Day Scholars'. Fr. Provincial appreciated and encouraged the promotion of the Breakfast Scheme. It was decided to initiate 'Breakfast Scheme for Day Scholars of shift I' at the start of the next academic year 2021-22.

Fr. Provincial appreciated members of the Governing Body for their active participation and meaningful suggestions during the meeting.

Fr. Principal in-charge acknowledged the support and encouragement provided by Fr. Provincial towards the growth and development of the college. He thanked every member for active participation and support towards the quality enhancement of the college.

The meeting came to an end at 1.15 p.m.

## MINUTES OF THE GOVERNING BODY MEETING

Date: 24.03.2021 Venue: Conference Hall Time: 10:30 am

The Governing Body meeting of the college was held on Wednesday, 24th March 2021, at 10:30 a.m. in the Conference Hall. Rev. Dr. Alphonse Manickam, S.J., Secretary, evoked God's presence through prayer. Rev. Dr. Danis Ponniah S.J., Chairman & Provincial, Jesuit Madurai Province, Prof. K. Ramamurthy Naidu, UGC nominee, Dr.S.P. Victor, Dean of Science, and Rev. Dr. A. Ignacy, S.J., Vice Principal, could not attend the meeting for various reasons. In the absence of the Chairman, the Vice-Chairman Rev. Dr. V. Henry Jerome, S.J., chaired the Governing Body meeting.

Rev. Dr. V. Henry Jerome, S.J., Vice-Chairman of the Governing Body & Rector, gave an introductory note, appreciating the college for initiating quality programmes online in spite of the difficulties due to the Covid situation. Then he asked Rev. Dr. S. Mariadoss S.J., Principal i/c, to welcome the participants. When Rev. Dr. S. Mariadoss S.J., began his Welcome Address, Dr. S. Samuel Asir Raj, University Nominee, expressed his dissent over the composition of the College Governing Body. Referring to the guidelines of the Manonmaniam Sundaranar University on the constitution of a college governing body, he asked the Vice-Chairman the justification for the inclusion of Special Invitees in the Governing Body of St. Xavier's College. The Vice-Chairman asked the Principal i/c to respond. Rev. Dr. S. Mariadoss, S.J., Principal i/c, replied that the presence of the Special Invitees-Rev. Dr. S. Arul Ravi S.J, Vice-Principal, Dr. L. Louis Jesudass, Controller of Examinations, Mr. S. Benjamin Franklin, Dean of Arts, Dr. M. Baby Mariyatra, Dean of UGC Affairs & Research, and Dr. A. Lourdusamy, IQAC Coordinator-was necessary to discuss the quality initiatives pertaining to the governance of the college and that those Special Invitees had contributed to the growth of the college to a great extent, especially in getting 3.66 CGPA in NAAC Accreditation in September 2019. He further said that the Special Inviteess would not vote if there was any voting on a particular issue. Rev.Dr.D.Thomas Alexander S.J., Province Coordinator for Higher Education, added that the Special Invitees were dedicated academicians who had contributed to the academic excellence of the college and that they should be allowed to attend the meeting. But Dr. S. Samuel Asir Raj, University nominee, insisted that the Special Invitees should not attend the meeting. Rev. Dr. Alphonse Manickam, S.J, Secretary, said that as per the UGC guidelines,

the three members of the Academic Council nominated by the university must be not less than the rank of a professor but the University had sent Associate Professors as nominees, and the college accepted the nominees of the university. He also asked why Dr. S. Samuel Asir Raj was insisting on sending the Special Invitees out. Dr. S. Samuel Asir Raj replied that the college may ask clarification from the university regarding the appointment of Associate Professors as nominees for Academic Council. The other members said that the dissent of Dr. S. Samuel Asir Raj could be registered and that the meeting should continue.

Once again, the Vice-Chairman invited the Principal i/c to welcome the members of the Governing Body. Then the Minutes of the previous meeting held on 6<sup>th</sup> November 2020 and the Action Taken Report were read out by Dr.V.S.Joseph Albert, Deputy Principal. Fr. Principal i/c added that the college was discussing with the NCC Officers and that if "C" certificate could be awarded to Shift II students, the possibility would be explored. Then the minutes were confirmed.

When the Vice-Chairman Rev.Dr.V.Henry Jerome, S.J. asked Mr. S. Benjamin Franklin, Dean of Arts, to present the minutes of the previous Academic Council meeting held on 24th February 2021, Dr. S. Samuel Asir Raj, University Nominee, without getting permission from the Vice-Chairman, said directly to Mr. S. Benjamin Franklin: "We cannot accept you speaking here". Dr. G. Ezhilan, Regional Joint Director of Collegiate Education & State Government Nominee, said that the decision of allowing the Special Invitees to attend the meeting should be left to the discretion of the Vice-Chairman. But the University Nominee was not convinced and he insisted that Principal i/c should present the minutes. Dr.S.Arul Raj, Associate Professor & Head, Dept. of Mathematics, suggested that the agenda of the meeting should be followed and let the proceedings move on. Then the Vice-Chairman said that the dissent of the University Nominee would be registered and that the meeting should continue with the Special Invitees for the benefit of students. The minutes of the previous Academic Council meeting were presented by Mr.S.Benjamin Franklin, Dean of Arts. Then Dr. S. Samuel Asir Raj said that the Academic Council minutes should not be approved because the three University Nominees for Academic Council had not signed the minutes. Fr. Principal i/c said that once the minutes were approved by the Governing Body, it would be shared to the university nominees of the Academic Council. Dr. S. Samuel Asir Raj asked why there was an adhoc chairman appointed in the Board of Studies of Economics. The Province Higher Education Coordinator replied that the same question was raised in the



Academic Council and it was replied by the Chairman of the Academic Council in the meeting held on 24th February 2021. Dr. V. S. Joseph Albert said that the revised syllabus for all UG and PG programmes was to be introduced in June 2021 and that the refusal to approve the Academic Council minutes would go against the welfare of the students. He said that the Academic Council minutes should be sent to the three University Nominees as early as possible and if there was any correction, it could be ratified in the next Governing Body meeting. Dr. S. Samuel Asir said that Dr. V. S. Joseph Albert should not speak because he was a Special Invitee. Fr. Principal i/c replied that Dr. V. S. Joseph Albert was not a Special Invitee and added that he was one of the five members representing the Management.

Dr. V. S. Joseph Albert read out the UGC guidelines for the Autonomous Colleges, notified in the Gazette of India on February 12, 2018. Dr. S. Samuel Asir Raj said that Manonmaniam Sundaranar University neither approved nor ratified those UGC guidelines notified in the Gazette of India. The Vice-Chairman said that the college would seek clarification from the UGC. Then the minutes of the Academic Council were approved after registering the dissent expressed by Dr. S. Samuel Asir Raj.

Dr. M. Baby Mariyatra, Dean of Research & UGC Affairs, was asked by the Chairperson to present the minutes of the Finance Committee meeting held on 10<sup>th</sup> March 2021. The University Nominee expressed his dissent to the presentation by Dr. M. Baby Mariyatra. It was registered and then Dr. M. Baby Mariyatra read out the minutes of the Finance Committee meeting. The minutes were confirmed by the members of the Body.

After registering the dissent expressed by Dr.S.Samuel Asir Raj, Dr.A.Lourdusamy, IQAC Coordinator, presented the IQAC report, highlighting the quality events implemented during 2020—2021. He informed the members that the IQAC submitted data to NIRF in January 2021. He said that IQAC facilitated various departments of the college to conduct 86 online webinars. The members appreciated such academic initiatives. The University Nominee suggested that fund could be availed from NHRC for conducting webinars and similar programmes on human rights.

After registering the dissent expressed by Dr. S. Samuel Asir Raj, the semester results November 2020 were presented by Dr. L. Louis Jesudass, Controller of Examinations. He said that Odd Semester examinations of November 2020 were conducted online in two phases; the first phase for II UG, III UG and II PG students from 02-12-2020

to 10-12-2020 and the second phase for I UG and I PG students from 14-12-2020 to 21-12-2020. 3906 students appeared for the exam while 3705 passed with an overall pass percentage of 94.85. The pass percentages recorded in UG courses and PG courses were 94.57 and 98.46 respectively. The members of the Governing Body acknowledged the efforts taken by the Controller and his team and confirmed the report.

Under any other matter, Fr. Principal i/c informed that the endowment lecture created in the name of Dr. L. Louis Jesudass had not been conducted by the Department of Botany for the past three years and therefore he asked whether that endowment could be converted into endowment scholarship for the benefit of the students. It was accepted by the members and it was decided to convert Dr. L. Louis Jesudass Endowment Lecture as Dr.L.Louis Jesudass Endowment Scholarship.

Dr. S. Paul Raj, Associate Professor of Physics, requested the Vice-Chairman of the meeting to look into the situation prevailing between a group of aided Staff Members and the College Management. The University Nominee also was raising his concern over that issue. The Vice-Chairman replied that the College Management would take appropriate steps for the progress of the institution.

Dr. G. Ezhilan, Regional Joint Director of Collegiate Education & State Government Nominee, said that the minutes presented showed that the Officials, Teachers and Non-Teaching Staff had taken good initiatives for promoting the academic excellence of the college.

Then the Principal i/c proposed a vote of thanks. While thanking all the present members profusely for participation, he acknowledged the contribution of former members of the Governing Body, Dr. Latha Poornam, (Former Regional Director of Collegiate Education, Tirunelveli), and Dr. Ganeshram, (Principal, SRNM College, Sattur & University Nominee), to the growth of the college.

The meeting came to an end at 12:15 p.m.

# Corrections to be Carried Out in the Minutes of the Governing Body Meeting held on 24.03.2021 at St. Xavier's (Autonomous) College

Dear Dr. M. Baby Mariyatra, I apologise for not sending the my comments regarding the Minutes much earlier in the day. But I request that the following changes printed in italics, may be carried out in the Minutes of the Governing Body.

#### In Paragraph 1:

"In the absence of the Chairman, the Vice-Chairman Rev. Dr. V. Henry Jerome, S.J., chaired the Governing Body meeting as acting Chairperson."

#### In Paragraph 2:

"When Rev. Dr. S. Mariadoss S.J., began his Welcome Address, Dr. S. Samuel Asir Raj,
University Nominee, wanted to know the members of the Governing Body in accordance to
MSU Act 1990 & Statutes and expressed his dissent over the presence of seven Special Invitees
in the College Governing Body and in addition to the three members nominated by the Trust /
Management there were three other members, namely: The Treasurer Rev. Dr. F. X. Dominic
Royce S.J., the Deputy Principal V.S. Joseph Albert and the Province Coordinator for Higher
Education, Rev. Dr. D. Thomas Alexander S.J.. The Ex- Officio Member Secretary who was the
Principal in charge replied that according to the UGC Regulations of 2018, five members could be
nominated by the Trust / Management to the Governing Council. Dr. S. Samuel Asir Raj replied that
the UGC Regulations, 2018 were approved by the Government of Tamil Nadu only in January
2021 and since the Model Code of Conduct was in vogue due to the Elections, The MSU
Syndicate could not meet to approve the UGC Regulations of 2018. Hence Dr. S. Samuel Asir Raj
specified that only the MSU Act 1990 and Statutes were the only legal document that detailed
the Membership of the Governing Council of an Autonomous College which was to be followed.

### In Paragraph 4

Dr. G. Ezhilan, Regional Joint Director of Collegiate Education & State Government
Nominee, said that the decision of allowing the Special Invitees to attend the meeting
should be left to the discretion of the Vice-Chairman. But the University Nominee was not
convinced and he insisted that Principal i/c should present the minutes. It was very clear that Dr.
G. Ezhilan only spoke about attending of the General Body Meeting by the Special Invitees and
not regarding presentation of minutes by a Special Invitee which is violation of norms
Manonmaniam Sundaranar University Act 1990 & Statutes. So, Dr. S. Samuel Asir Raj insisted
that the minutes of the various Minutes can be presented only by the Ex-Officio Member
Secretary who is the Principal of the College and not by any Special Invitee.

Dr. S. Samuel Asir Raj asked why there was an Ad hoc chairman appointed in the
Board of Studies of Economics. The Province Higher Education Coordinator replied that
the same question was raised in the Academic Council and it was replied by the
Chairman of the Academic Council in the meeting held on 24th February 2021, but no
reasonable explanation was given in the Governing Body Meeting But no satisfactory explain
was given either by the acting Chairperson or the Member Secretary who was the Principal-in-

charge of the College.

Dr. V. S. Joseph Albert said that the revised syllabus for all UG and PG programmes was to be introduced in June 2021 and that the refusal to approve the Academic Council minutes would go against the welfare of the students. He said that the Academic Council minutes should be sent to the three University Nominees as early as possible and if there was any correction, it could be ratified in the next Governing Body meeting. But Dr. S. Samuel Asir took the stand that on account of not having obtain signature of approval for the Academic Council Minutes from the University Nominees and also because no satisfactory explanation was received regarding the presence of the Ad hoc Chairperson who presented the Minutes of Board of Studies in Economics, the New Syllabi could only be ratified in the next General Body Meeting. Dr. S. Samuel Asir said that Dr. V. S. Joseph Albert should not speak because he

Invitee and added that he was one of the five members representing the Management.

### In Paragraph 9:

Under any other matter, Fr. Principal i/c informed that the endowment lecture created in the name of Dr. L. Louis Jesudass, *who had retired*, had not been conducted by the Department of Botany for the past three years and therefore he asked whether that endowment could be converted into endowment scholarship for the benefit of the students. It was accepted by the members and it was decided to convert Dr. L. Louis Jesudass Endowment Scholarship. *Dr. S. Samuel Asir Raj wondered whether UGC Regulations permitted a retired person to be reemployed in the College and requested the Acting Chairperson and the Ex- Officio Member Secretary to get clarification on the issue at the earliest.*
