The Minutes of the Governing Body Meeting

Date: 08.12.2021

Venue: Conference Hall

Time: 10. 00 a.m.

The first Governing Body meeting of the academic year 2021-22 was held on 08.12.2021 at 10.00 a.m. The meeting started with a prayer said by Rev. Dr. Alphonse Manickam, the Secretary of the College. Rev. Dr. Danis Ponniah S.J., Provincial, Jesuit Madurai Province, Prof. K. Ramamurthy Naidu, UGC Nominee, and Dr. R. Baskaran, RJDCE, Tirunelveli Region were not able to participate in the meeting due to various reasons. The Vice-Chairman Rev. Dr. Henry Jerome, Rector of St. Xavier's Institutions, Palayamkottai chaired and conducted the meeting. The Vice-Chairman greeted and welcomed the members with the introductory note emphasizing that we have the responsibility of moulding the students for a better future. He said that except a few highly motivated students, all other students require special attention. He urged all the members of the board reflect the present situation and contribute to the academic excellence in the campus.

Dr. S. Mariadoss S.J., Principal, read the minutes of the previous Governing Body meeting held on 24.03.2021 and the action taken report. Dr. S. Samuel Asir Raj, University Nominee, informed that he had sent some queries and clarifications regarding the minutes of the previous Governing Body Meeting and he wanted to know whether the corrections were carried out or not. The Principal replied that the modifications were incorporated wherever applicable. Consequently, the minutes were confirmed by all the members. In the action taken report, the Principal mentioned that it has been applied to offer NCC for Shift II students and the college is awaiting reply from the concerned authorities.

Dr. S. Samuel Asir Raj expressed his dissent over the presence of special invitees. The Vice-Chairman replied that UGC has recommended the composition of various Statutory Bodies which is not the minimum requirement for the composition and therefore special invitees are present in various statutory bodies of the College to discuss quality measures to be implemented. The University nominee said that the 2018 guidelines of UGC have not yet been accepted and implemented by the Government of Tamil Nadu and Manonmaniam Sundaranar University, Tirunelveli. Rev Dr. Alphonse Manickam, the Secretary mentioned that St. Xavier's College is having the practice of including special invitees in various statutory bodies since UGC conferred autonomy to the College. Rev. Dr. Thomas Alexander also supported the presence of special

invitees. Dr. A. Lourdusamy, Director-IQAC pointed out that the special invitees and section invitees. Dr. A. Louidasans, Commission meeting of University Grants Commission. The Principal expresses and it is highly discouraging to note that the university nominee is implement quality measures and it is highly discouraging to note that the university nominee is umplement quality and the special invitees from the Governing Body as he did in the very particular about excluding the special invitees from the Governing Body as he did in the very particular about Properties of the dissent raised by the university nominee, Dr. previous General Body meeting. In response to the dissent raised by the university nominee, Dr. M. Baby Mariyatra. with the permission of the Vice-Chairman, read the DC proceedings published on 11.01.2021: "The University Grants Commission has notified its Regulations on Minimum Qualifications ... and Measures for the Maintenance of Standards in Higher Education, 2018 on 18.07.2018 vide the Notification second read above. The Government, after careful examination, have decided to adopt the UGC Regulations, ... in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018 to the Teachers and other Academic Staff in the Universities under the control of Higher Education Department and Government / Government aided Colleges in toto with minor modifications with effect from 01.04.2020". Hence, Dr. Samuel Asir Raj accepted the presence of special invitees and the Vice-Chairman passed the minutes with the approval of all the members.

The Finance Committee minutes were read by Dr. M. Baby Mariyatra, Dean of Research and UGC Affairs. Rev. Dr. Dominic Royce, the Procurator asked whether UGC has sanctioned Autonomy Grant recently. Dr. M. Baby Mariyatra replied that the UGC confirmed that the Autonomy Grant for the academic year 2020-21 could not be released due to paucity of funds. The proposal for Autonomy Grant for the academic year 2021-22 has been sent. The Principal informed that under "Sophisticated Analytical & Technical Help Institute (SATHI) DST has called for proposal to set Sophisticated central Instrumentation Centre for a maximum of Rs. 125 crores if the management is willing to contribute 25% of the sanctioned fund. He informed that a proposal to the tune of 2 Crores will be submitted to DST and the management will have to contribute 25% if SATHI programme is sanctioned. The Board welcomed and approved such a move and appreciated the management for its readiness to contribute 25% of the amount to be sanctioned for the betterment of the college. Dr. Samuel Asir Raj added that ICSSR is offering funds for conducting seminars and conferences and asked the college to use the opportunity.

The minutes of the Planning and Evaluation Committee were read by Dr. S. Arul Raj. Dr. Samuel Asir added that South Indian Commerce Council promotes skill development and

suggested the College to give a try. He also appreciated the Principal for taking initiatives to offer a course based on skill development which is the need of the hour in this area.

The minutes of the Academic Council were presented by Dr. S. P. Victor, Dean of Science. Dr. Samuel Asir Raj enquired the reason for the pass percentages in the Departments of Visual Communication (76.92%) and Computer Science (73.47%). Rev. Fr. Ignacy S. J. informed that the low pass percentage in the Department of Visual Communication is due to the inability to give studio experience for the students and conduct of online practical examination through Viva-voce mode. Dr. S.P. Victor clarified that the practical examinations were conducted online through viva-voce mode and the students were not able to answer the theory questions asked. It was suggested to use the exact pass percentage instead of using the phrase "low pass percentage" while mentioning the results in the minutes.

When the question was raised regarding the closure of the IT course, it was clarified by the Principal that the course was closed based on the suggestion of the Standing Committee since no application was received for the last three years. The Principal informed that proposed new course is renamed from BMS Logistics Management to B.Com Maritime Logistics. He also insisted that the course offers apprenticeship, not internship in the fifth and sixth semesters.

The Principal initiated the idea of introducing internship to all UG students. It was decided that the departments are expected to have discussion on this matter in the Boards of Studies and send the recommendations to the Academic Council. This topic is to be discussed further in the next Governing Body for making further decision. The Rector expressed concern over the difficulty of finding suitable work place for internship. The IQAC Director suggested that the number of days can be reduced for Internship. When the University nominee asked how the college got an opportunity to start a course like BMS Management Science, the Principal disclosed that Logistics Sector Skills (LSC) chooses institutions based on merit and other infrastructure facilities. St. Xavier's College is around 50 km radius of Tuticorin Port; it is an added advantages to the college.

Rev. Dr. S. Arul Ravi S.J. presented the report of the admission committee. In the academic year 2020-22, the college received 8990 applications and 1585 students were admitted. The report also mentioned that the M.Phil programmes are suspended, based on the suggestion of the Standing Committee, in our college since only three applications were received

in the previous academic year 2020-21. Rev. Dr. Alphonse Manickam S.J. suggested that the statistics like the admission of Catholic students can be included in the report since our college is a minority institution.

Dr. S. Athisayanathan, Controller of Examinations, presented the semester results of 2020-21 even semester. As per the report, the even semester exam was held from 28th April to 8th May 2021 and 15th June to 17th June 2021. The semester examination was conducted for 3852 students. The Even semester results were declared after 13 days from the last date of examination. About 3758 students passed with an overall pass percentage of 98%. The pass percentage of UG courses is 97% and PG courses is 99%. Dr. Samuel Asir Raj asked whether the questions are set by the internal or external examiners. The controller replied that the semester questions are set by the externals except for UG Part-II and Part- IV.

Dr. A. Lourdusamy presented the report of IQAC. He informed that the college secured 67th Rank in India Ranking 2021 under National Institutional Ranking Framework (NIRF) initiated by MHRD. He also informed that IQAC conducted 7 online programmes and one offline programme for students and staff from the beginning of this academic year. It also assisted other departments to conduct 87 online programmes in 2020-21. He listed three reasons for not getting good rank in NIRF as follows:1. Research: there is quality of papers but quantity of papers published in Scopus and Web of Science are less. 2. We did not receive financial assistance from various funding agencies in the academic year 2020-21. So, we could not have high amount for utilization of financial resources including salary component. 3. Placement: The number of companies visiting the campus for recruitment is to be increased as it is important to get high score in the parameter- Perception. To rectify the short falls, it is suggested to appoint a full-time placement officer and conduct job fair in the college. The Rector thanked Manonmaniam Sundaranar University for giving permission to the stand alone inter-disciplinary research center Xavier Research Foundation (XRF). Dr. S. Samuel Asir Raj appreciated the college for this new venture and he pointed out that, in the past, the contribution of Jesuits to research was commendable. He asked the members to motivate the staff members to work on minor and major research projects. The Principal also stressed the importance of increasing the research activities in the campus through various means. The Rector informed that seed money will be increased for research and it is to be included in the next budget.

Rev. Dr. Alphonse Manickam S.J., presented the Secretary's Report which included the appointment of new officials, teaching and non-teaching staff. The report informed that the teaching staff Dr. P. Xavier Raj (Mathematics) and the non-teaching staff Mr. M. .Rayappan retire in May 2022. Dr. A. Lourdusamy (Mathematics) and Dr. Francis Xavier (Tamil) retire in June 2022, Dr. J. Amalanathan (Economics) retires in July 2022. He also informed that due to heavy rain, most of the UPS, projectors, batteries, printers, computers had to be either repaired or replaced. A new Electro- Chemical Workstation suggested by the inspection team of the University was established in Physics Lab for research promotion. In total, Rs. 45, 40, 442/- is spent so far in 2021-22 for the improvement of the infrastructure of the college.

Under any other matter, Dr. S. Samuel Asir Raj asked if the qualification of the Principal is fulfilled. The Secretary replied that Dr. S. Mariadoss S.J has already met all the requirements of the UGC to become a principal. The details have been sent to the concerned authorities for the approval.

The Principal thanked all the present members for their contribution and also he acknowledged the contribution of the former members of the Governing Body. The Meeting ended at 12.15 p.m.

The Minutes of the Governing Body Meeting

Date: 25. 5. 2022

Venue: Conference Hall

Time: 10. 00 a.m.

The 68th Governing Body meeting of the academic year 2021-22 was held on 25.5.2022 at 10.00 a.m. The meeting started with a prayer said by Dr. B. Xavier Innocent, Deputy Principal. Rev. Dr. Danis Ponniah S.J., Provincial, Jesuit Madurai Province, Rev. Dr. Alphonse Manickam, Secretary of the College, and Dr. R. Baskaran, RJDCE, Tirunelveli Region were not able to participate in the meeting due to various reasons. The Vice-Chairman Rev. Dr. Henry Jerome, Rector of St. Xavier's Institutions, Palayamkottai chaired and conducted the meeting. The Vice-Chairman greeted and welcomed the members. He emphasized the need for helping the students to cope with the new normalcy. He highlighted the following Jesuits pointers with which the college functions: Catholic, Committed to dialogue with other religions, Global citizenship, Care for all creatures, justice and being accessible to the marginalized and the poor. He urged all the members of the board reflect the present situation and contribute to the academic excellence in the campus.

Dr. S. Mariadoss S.J., Principal, read the minutes of the previous Governing Body meeting held on 8- 12- 2021 and the action taken report. Dr. S. Samuel Asir Raj, University Nominee, informed that in the minutes instead of ICHR it is wrongly mentioned as ICSSR. Next, he claimed that the Principal is an Assistant Professor and he cannot be called as Principal instead it may be mentioned as Principal i/c. The Principal replied that he has already met all the qualifications required for a Principal and the documents are in the RJD office. The Vice-Chairman Rev. Dr. Henry Jerome informed that the process gets delayed in the university and the RJD office. Dr. K. Ramamurthy Naidu, UGC Nominee intervened and said that Kothari Commission (1964) has given some autonomy for Autonomous colleges. Based on this, a college appoints the Principal and the proposal for approval is sent to the Regional Joint Director and the Vice Chancellor of the University. When it is delayed from the office side, the college cannot be held responsible. He also requested Dr. S. Samuel Asir Raj to talk to the Vice Chancellor and help the college to get the approval at the earliest. The UGC nominee further said that once a college completes third cycle of autonomy, then it has the potential to be elevated to Degree Awarding Status. At this juncture, he appreciated St. Xavier's College for completing the fourth cycle of NAAC accreditation at A++ Grade with a CGPA of 3.66 out of 4. He also stressed that the minutes need not be elaborate like this instead he suggested a table with three columns: Subject, Suggestion and Action Taken. He

further said that the complete minutes need not be read whereas important points (executive summary) can be highlighted.

Next, Dr. S. Samuel Asir Raj questioned the presence of special invitees and he claimed that they should not be allowed as per norms. Dr. S. Mariadoss S.J., Principal shared that the university nominee has been raising the two issues related to Principal's qualification and inclusion of special invitees for the past three Governing Body meetings which disrupts constructive discussion. He also registered his dissent over this issue. Dr. K. Ramamurthy Naidu, UGC Nominee clarified that under Autonomy, the special invitees can be permitted in all the academic meetings. He also informed that when he was the UGC Commission member, he had witnessed many serving as special invitees. He reiterated that for providing specialized opinion, special invitees were allowed in UGC Commission meeting and in various bodies of UGC. After all these deliberations, the minutes of the Governing Body were passed.

Dr. S. P. Victor read the minutes of the Academic Council held on 12-5-2022. Dr. K. Ramamurthy Naidu opined that the objective of autonomous colleges is to bring academic reforms. Hence, the details related to introduction of need based courses, new courses and the recommendations of the council can be highlighted in the minutes. The Principal pointed out that the suggestions are highlighted in the minutes. It was agreed to present an executive summary of the minutes followed by the detailed minutes. Dr. S. Samuel Asir Raj sought clarification for the availability of HoD i/c in the departments- Economics and Botany instead of HoDs. The Principal replied that the in-charges of these two departments are from the same department and soon there will be full-time HoDs. After this the minutes of the Academic Council were passed. The following resolutions were made by the Academic Council:

- 1. Major changes in the syllabus can be effected only in the next major revision in 2024.
- 2. However, minor changes in the syllabus are permitted from the third semester.
- 3. From the academic year 2022-23, internship is made compulsory. UG students will undergo 15 days during the summer holidays after Semester IV. PG students will undergo 21 days during the II semester holidays.
- 4. Tutor Ward system is extended to all the students from the next academic year.
- 5. Completing one course through MOOC is mandatory for PG students and UG students are encouraged to complete one online course.

The minutes of the Finance Committee meeting held on 21-3-2022 were read by Dr. M. Baby Mariyatra, Dean of Research and UGC Affairs. Dr. K. Ramamurthy Naidu asked regarding the details of the grant sanctioned and utilized. It was highlighted that the college has not received autonomy grant for the last two academic years 2020-'21 and 2021-'22. The UGC Nominee registered his displeasure regarding the non-availability of funds and asked the college to keep trying to receive the grants. He also promised to help the college to receive the autonomy grant. After these deliberations, the minutes of the meeting of Finance Committee were passed.

Dr. A. Lourdusamy presented the report of IQAC. The UGC nominee suggested to present the recommendations based on all the seven criteria of NAAC evaluation. Once again the UGC nominee appreciated the college for completing the fourth cycle of accreditation and recommended to apply for the Institute of Eminence. Dr. S. Samuel Asir Raj insisted that the Best Practices of the college can also be listed. The Principal said that he prefers the term "Unique Practices" instead of "Best Practices". The UGC nominee said that Best Practices are given less weightage in the assessment done by NAAC.

Since Rev. Dr. Alphonse Manickam S.J., Secretary was not present Rev. Dr. S. Mariadoass S.J. read the report of the Secretary. According to the report, the teaching staff Dr. P. Xavier Raj, Associate Professor, Department of Mathematics and the non-teaching staff Mr. M. Rayappan retire on 31st May 2022. Dr. A. Lourdusamy, Associate Professor, Department of Mathematics and Dr. Francis Xavier, Associate Professor, Department of Tamil retire on 30th June 2022. Dr. J. Amalanathan, Associate Professor, Department of Economics retires on 31st July 2022. Dr. A. Lourdusamy and Dr. Francis Xavier have submitted their application for re-employment. The decision on re-employment of Dr. A. Lourdusamy, and Dr. Francis Xavier will be taken by the management based on the government norms and their proposals will be forwarded to the RJDCE, Tirunelveli.

The Controller of Examination presented the results of the ODD semester (November-2021) examinations held from 1stFebruary to 11thFebruary 2022. The semester examination was conducted for 4093 students by setting 394 questions by subject experts. There were 187 examiners. In total, 3826 students passed with an overall pass percentage of 93%. The pass percentage of UG courses is 93.02% and PG courses is 98.7%. The results were declared on 3rdMarch 2022.

Under any other matter, Dr. K. Ramamurthy Naidu asked the staff members to apply for Indo-US grant and Travel Grant for attending seminars and conferences. The Principal asked the UGC nominee about the availability of special grants for 100 year old institutions since St. Xavier's College celebrates its Centenary in 2022- 2023. The UGC nominee informed that there are special funds and asked the college to apply for it.

Rev. Dr. D. Thomas Alexander, S.J., Province Co-ordinator for Higher Education & Principal, St. Xavier's College of Education thanked the UGC nominee for clarifying doubts regarding the qualification approval of the Principal and the inclusion of Special Invitees in Statutory Committees. He also stressed the need for networking among the faculty members and institutions for the betterment of the student community. He also suggested to explore the possibility of student exchange programmes and faculty exchange programmes among the Jesuit institutions like Arulanandar College, Karumathur, St. Joseph's College, Trichy and Loyola College, Chennai.

The Principal thanked all the members for their contribution and meaningful discussion. Especially he thanked Dr. K. Ramamurthy Naidu, UGC nominee for his valuable input and clarifying doubts on important issues. The Meeting ended at 12.15 p.m.


